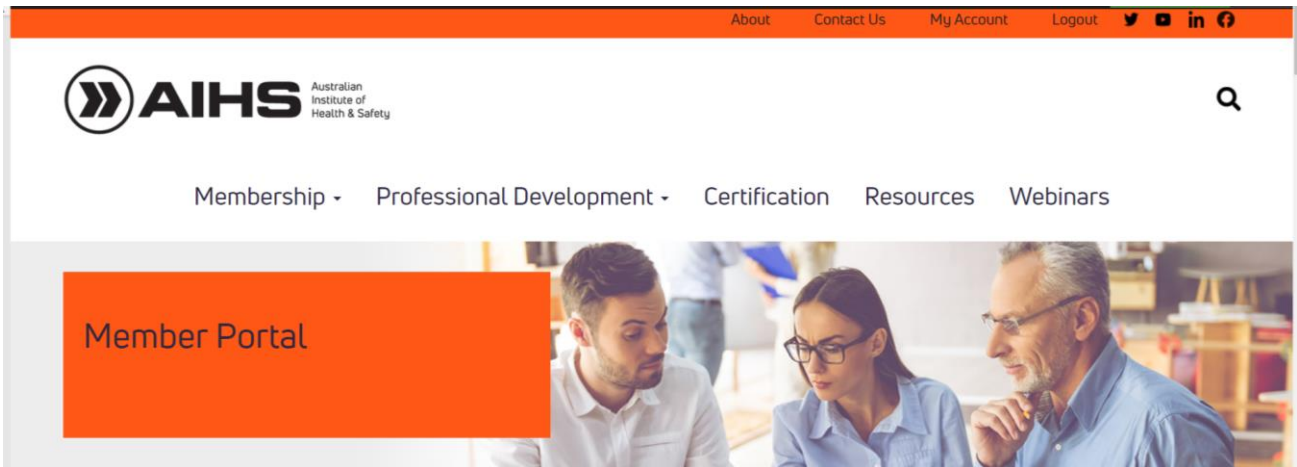

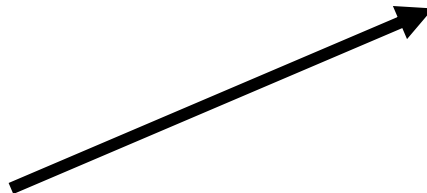

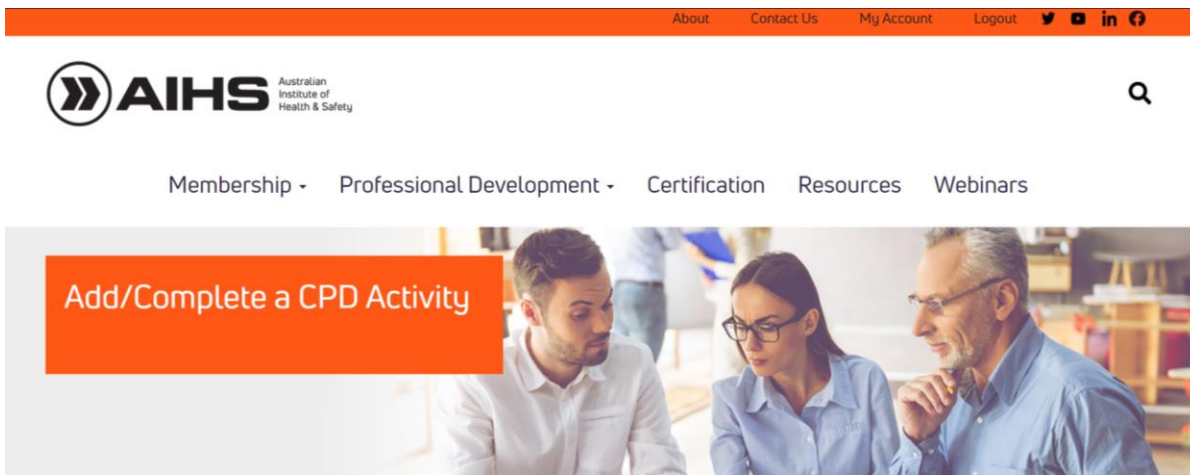

- Attend & Reflect on CPD based Webinar (per hour)
- University studies in WHS or closely related area, with assessments
- Develop and present a guest lecture at university or conference per hour
- Attend & Reflect on each Mentoring Session as a Mentee or as Mentor
- Submit a peer reviewed Journal Article for publication
- Prepare or Substantially Revise a BOK chapter
- Prepare & Coordinate a substantial Submission in response to Government/Regulator Consultation
- Provide Significant Input into a Government/Regulator submission
- Prepare & Publish an Article in an OHS professional/trade journal
- Self education in an OHS related field. Provide evidence of personal study and learnings. Per topic.
- Prepare & Publish a LinkedIn or other Social Media Article which covers an OHS issue in detail
- Review & Comment on OHS Journals, OHS BOK Chapters, Magazines and Articles
